1. Introduction — Greg Shatan

IPC President, Greg Shatan, welcomed and thanked participants for joining the monthly IPC Membership meeting. Greg acknowledged the IPC's newest member, Tommaso La Scala to the Constituency.

2. Report from Council - Heather Forrest & Paul McGrady

Heather Forrest and Paul McGrady gave an overview of the upcoming agenda and updates from ICANN56, including the following:

- 1. **GNSO New Rights and Responsibilities Under the Revised Bylaws** Heather noted that Paul's motion for the GNSO's New Rights and Responsibilities passed, and the call for volunteers has gone out. Paul encouraged IPC members with experience working on the ICANN bylaws and/or the operating procedures for the GNSO to apply.
- 2. **Westlake's Recommendations** Implementation plans of the recommendations approved by the GNSO Council and the ICANN Board. Heather noted not all of Westlake's recommendations were approved. It was suggested in Helsinki that this could be done through the Standing Committee of Improvements (SCI). This will be used as a starting point.
- 3. **Approval of Candidates for the CSC** Under the new bylaws, the CSC is the new standing committee that empowers the community in regards to the IANA functions. A call for volunteers has gone out to the SO AC Chairs. The selection committee is meeting later in July to choose the liaison and alternatives for the role.
- 4. **GAC Communique** Two items of note were a.) the Red Cross' request for renewal of protections from temporary to permanent, and b.) the PPSAI
- 5. **Whois conflict-** There is a motion that predates the Helsinki meeting, which Heather has discussed with Steve Metalitz for his expertise.

Paul noted, as a FYI to membership, that his motion that was shared with the IPC list to allow the GNSO Council to opine that the work on jurisdiction formation was adequately handled in Work Stream 1, and does not need to be reopened.

3. Dues - Greg Shatan on behalf of Lori Schulman

Greg Shatan provided a brief update on behalf of Lori Schulman (IPC Treasurer), who was participating at the UN's IGF program in New York, which conflicted with today's IPC Membership meeting.

Members should have received their invoice for 2016, which was sent as of July 6th, much later than usual given the new membership automation website, Memberclicks. Per the bylaws, invoices are usually sent in March and members are given a 60-day grace period within which to renew.

4. Website Update - Grea Shatan

Greg Shatan updated the IPC on the new Memberclicks website, noting that that it is currently undergoing a soft roll-out. The Domain name ipconstituency.org has yet to be pointed at it, but is forthcoming.

Greg Shatan gave an overview of the IPC's work in Helsinki, including the three bilateral meetings: IPC-RySG, IPC-RrSG, IPC-ALAC. A list of action items from these meetings if forthcoming and should be available by the end of the week. Greg thanked Patrick Charnley for his coordination of the IPC "No-Host" dinner in Helsinki.

IPC-RySG Action Item: Small team from each group to come up with a list of items that should be on-going discussions between the two groups, so that in Hyderabad the next bi-lateral meeting can build off of the work done in between.

6. ICANN57 Hyderabad Planning

Heather Forrest shared that the GNSO Council is working on the base GNSO Schedule resolved as soon as possible. A request will go to the list regarding IPC travel support for ICANN57 within the next few weeks.

7. IPC Elections - Fabricio Vayra

Fabricio Vayra (IPC Secretary), announced the IPC elections which are coming up, noting that the GNSO Council elections will take place in the next few months. Given the new timeline, the elections will take place sooner than usual.

Fabricio announced that IPC Leadership had agreed to hold an initial election for the one GNSO Council seat in August, and proceed with IPC leadership positions later this fall. Heather Forrest has announced her intent to run for reelections. Fabricio suggested that any other candidates submit their nominations to him within the upcoming weeks. The Councilor has to be announced and finalized by September 7th, and a minimum of three weeks prior to the September 7th date is needed for the IPC election.
