MEETING IPC Membership Meeting

1. Introduction — Greg Shatan

IPC President, Greg Shatan, welcomed and thanked participants for joining the monthly IPC Membership meeting.

2. Report from Council - Heather Forrest & Paul McGrady

Heather Forrest and Paul McGrady updated the IPC on the GNSO Council meetings held over the last few weeks. Heather noted that the Council agenda for the GNSO session during ICANN57 is forthcoming and presented on the two following items:

- 1. **GNSO Rates and Responsibilities Report** including the minority statement, which will be discussed during the ICANN57 meeting.
- 2. IGO, INGO, and Red Cross Names discussion Heather and Paul highlighted the discussion within Council regarding the GAC and Board's involvement in the IGO, INGO, and Red Cross names discussion. Greg provided background regarding the first IOC/RCRC Working Group where the Red Cross participated. It was agreed to hold an IPC meeting prior to the face-to-face Council meeting to discuss this topic, and any other items on the agenda.
- 3. GNSO Bylaws Discussion The current bylaws state that the GNSO Council is only a policy management body. It was agreed to discuss what the next steps should be, and what a statement should look like in Hyderabad. It was noted that the IPC should raise issue of GNSO Council Powers pursuant to ByLaws and/or insist on a public comment period for transparency reasons.

A Policy call will be held for next week to discuss some of these items in further detail before ICANN57.
