Brian Scarpelli updated the IPC on the various tools he has implemented to support the IPC's policy work. Recently, a Google calendar has been established to track public comments, and when they close.

Brian also mentioned that he will be developing a Newsletter, as a fourth tool, that will be sent at the beginning of each week. The purpose of this is to reduce the flow of emails, and have a central place where information about upcoming comments can be found, and coordinated amongst drafting teams.

3) Working Groups: Current Issues and ICANN59 planning (Greg Shatan)

a. RPM Working Group

Lori Schulman updated the IPC on recent events within the RPM Working Group. Further discussions will take place after the next RPM call, scheduled for tomorrow.

b. RDS Working Group

Steve Metalitz discussed the RDS Working Group, and noted that the most recent call the group learned that staff is moving ahead to enter into an agreement within the next 30 days with an independent law firm to provide some responses, independent views on the EU General Data Protection Regulation (GDPR), and how that might impact some of the group's work. They are going to ask the law firm to comment on the questions that were posed to the European Data Protection experts who spoke at the last ICANN meeting. It was noted that GDPR seems to be of increasing importance within ICANN.

The penalties of the GDPR range from \$25,000 per occurrence up to 4 percent of a registrar's complete income. It was commented that ICANN is basically saying that it is not going to provide guidance to registrars. The IPC agreed that further clarification is needed, based on ICANN's remarks to the registries and registrars at the most recent GDD Summit. GDPR is a High Interest Topic (HIT) for ICANN59.

ACTIONs:

- The IPC members agreed to reach out to their company counter parts in Europe to find out more information, and perhaps engage a law firm to write a white paper on the topic from an IP perspective.
- Lori agreed to have INTA's data protection committee look into GDPR.
- Steve agreed to develop a list of possible firms for circulation within the next few days.
