**1. Introduction**

Greg Shatan welcomed IPC members to the meeting, noting the new format of a 60-minute call for business, and reminding IPC members that Policy will be discussed on the regularly held Policy call, which is scheduled for next week.

**2. Report from Council (Heather& Paul)**

Heather Forrest noted that most discussion items will be left for the Policy call, but updated the IPC on the following items:

- **Empowered Community Vote-** The GNSO Council meeting was moved, in order to allow time for the GNSO, and the Empowered Community, to review the ICANN FY18 budget. No petitions were made against the budget for FY18.
- **GAC Communiqué vote** – Heather noted that the GNSO Council will vote on the GNSO response to the GAC communiqué, and looked forward to discussing this item further on the IPC Policy call.
- **Cross Community Working Group (CCWG) on Internet Governance** – Paul noted to IPC members that this is a topic undergoing discussion within the GNSO Council, and will be discussed during next week’s policy call, as Heather and Paul will need instruction on what the IPC position will be.

Heather noted that the next GNSO Council call will be held on 24 August 2017.

**3. Dues; Invoices (Lori)**

Lori Schulman, IPC Treasurer, reminded IPC members that invoices are due, and that renewal reminders have been sent to all IPC members. If you have paid your dues but haven’t received confirmation of payment, Lori asked for emails to be sent to herself and Chantelle Doerksen, IPC Secretariat.

- **IPC Travel Support to attend ICANN Public Meetings** – Lori reminded members that if they are a recipient of an IPC travel grant, that receipts are needed within 60 days of the ICANN meeting, and that members accepting travel funding are expected to be on the ground to attend all IPC, CSG, and policy meetings.

**4. GNSO Council Elections**

Greg announced that the GNSO Council elections need to be closed by 1 September 2017. Greg noted that Paul is up for reelection, and Heather Forrest still has one year left in her term, as they are staggered elections. Elections will begin in early August.
