1. Welcome and Introductions

Vicky Sheckler, IPC Vice President, opened the meeting with a welcome to members.

2. Membership/Outreach/Engagement Update

Kiran Malancharuvil, IPC Secretary, noted that the three new members had joined the IPC within the past month, and that the membership database is being reconciled in advance for

the GNSO Councilor election. Kiran estimated that an additional ten applications are awaiting processing.

For CROP, Kiran thanked Hector Manoff and Lori Schulman for inviting their local contacts for the IPC event.

3. ELECTIONS: GNSO Councilor & IPC Officers

Kiran reviewed the timeline for the GNSO Councilor election, noting that the nomination period opened today. Nominations should be sent to Kiran and the IPC Secretariat, Chantelle. In order to participate, invoices must be paid prior to the voting period.

4. Report from Council

Paul McGrady, IPC GNSO Councilor, initiated a discussion on the EPDP, providing an update of recent events. He outlined the work of the drafting team, noting the consideration of language put forth by the IPC.

Heather Forrest noted that the scope of the EPDP charter remains under discussion, with late amendments proposed after the agreed cut-off date for amendments. Going forward, further amendments will be managed by Council leadership as maker of the motion. Heather and Paul will update the IPC as work on the EPDP moves forward at the Council level.

The IGO INGO Access to Curative Rights PDP has been put forth for a vote. Petter Rindforth provided an update on the work of the PDP. The IPC will vote to support.

It was noted that the Analysis Group does not have a specific way of promoting the surveys, and that a call to action by IPC members to help promote responses may be necessary. Information on the surveys is forthcoming as it becomes available.
